## Brushy Creek Afterschool Registration Form Monthly Payment Plan & Commitment

Your child will be registered for all Afterschool months (school year August 2026 - May 2027). Installment bills will be withheld from the account on file on the 1<sup>st</sup> of every month. You must put a credit card on file to set up auto payment. A late fee of \$25 per family will be applied to your account on the 2<sup>nd</sup> of the month. If payment has not been received by the 5<sup>th</sup> of the month prior, your child will be withdrawn from the program. **Failure to process payments on time will result in the removal of your child from the program.**

**Cancellation Policy:** If you need to withdraw from the Afterschool Program, a written notice must be submitted to the Programs Supervisor 14 days in advance to avoid being charged for future billing. A \$25 administration fee per submission will be withheld.

**Late Pick Up Policy:** The Brushy Creek Afterschool program hours for children are from 2:55 p.m. to 6:00 p.m. each day. If you pick up your child later than 6:00 p.m. there will be a late fee incurred when children are not picked up by this scheduled time. The charge is \$1 per minute after 6:00pm. The fee will be applied to your account and must be paid with your monthly payment that is due on the 1<sup>st</sup> of the month. No cash will be accepted.
